§1. Purpose.

This local law is adopted for the purpose of increasing the number of members of the Board of Assessment Review of the Town of Delaware from three (3) members to five (5) members pursuant to Real Property Tax Law §522(1)(a).

§2. Increase in Membership of Board of Assessment Review.

The membership of the Board of Assessment Review of the Town of Delaware is hereby increased from three (3) members to five (5) members. The new members shall be assigned terms not coinciding with the terms of the existing members.

§3. This local law shall take effect immediately upon filing in the office of the Secretary of State.
