Local Law No. 7 of the year 19 99

A local law amending Local Law No. 1 of the year 1999 which regulates the conduct of Bingo by authorized organizations in the Town of Delaware.

SECTION I

Amendment of Local Law No. 1 of 1999

Local Law No. 1 of 1999 of the Town of Delaware is hereby amended as follows:

A. §6 of Local Law No. 1 of 1999 of the Town of Delaware, entitled "Prize Limits" is hereby amended to read as follows:

"§6 Prize limits.

A. No prize shall exceed the sum or value of one thousand dollars (\$1,000.00) in any single game of bingo.

B. No series of prizes on any one (1) bingo occasion shall aggregate more than three thousand dollars (\$3,000.00)."

B. A new §8-a is hereby added to Local Law No. 1 of 1999 of the Town of Delaware, to read as follows:

"§8-a Advertisement signs.

A licensee may advertise the conduct of an occasion of bingo to the general public by means of newspaper, circular, handbill and poster, and by one sign not exceeding 60 square feet in area, which may be displayed on or adjacent to the premises owned or occupied by a licensed authorized organization; and when an organization is licensed to conduct bingo occasions on the premises of another licensed organization or of a licensed commercial lessor, one additional such sign may be displayed on or adjacent to the premises in which the occasions are to be conducted. Additional signs may be displayed upon any firefighting equipment belonging to any licensed authorized organization which is a volunteer fire company, or upon any equipment or first-aid or rescue squad in and throughout the community served by such volunteer fire company or such first-aid or rescue squad, as the case may be. All advertisements shall be limited to a description of such event as "bingo," the name of the licensed, authorized organization conducting such occasions, the license number of the authorized organization as assigned by the clerk, and the date, location and time of the bingo occasion."

SECTION II

Effect of Invalidity

If any clause, sentence, phrase, paragraph or any part of this local law shall for any reason be adjusted finally by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or any part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby declared to be the legislative intent that the remainder of this local law would have been adopted had any such provision not be included.

SECTION III

Effective Date

This local law shall take effect immediately upon filing in the office of the Secretary of State.


